2.5.1 - Mechanism of internal assessment is transparent and robust in terms of frequency and mode. Write description within 200 words.

As per the Parent University Schedule, institution conducts internal test for both UG and PG Programmes in different modes to evaluate the conceptual level of students understanding and reportability. To maintain the regularity and punctuality students' attendance is considered for internal assessment.

Internal assessments are conducted in the form of home assignments, students' seminars, multiple choice question tests, internships and viva-voce. In each semester written tests are conducted, evaluated in stipulated duration and the evaluated scripts are returned to students for further self-feedback and improvement. All the results of assessments are declared and notified to the students by displaying on notice board and on college website. All the marks lists are counter signed by students, Incharge Teacher and Principal. Average marks scored by students will submitted by uploading on university portal. All these student assessment reports are discussed with parent by respective mentors for further progress at the end of every month. Internal Assessment is also conducted for experiential classes by Mock test or Preparatory test and reports are submitted to university. 5.3.2 - Institution facilitates students' representation and engagement in various administrative, co-curricular and extracurricular activities (student council/ students representation on various bodies as per established processes and norms )

IQAC of the college formulated the guidelines to motivate and engage the students in administrative and academic activities of the college. ## 6.2 - Strategy Development and Deployment

6.2.1 - The institutional Strategic/ perspective plan is effectively deployed

Implementation of short-term courses beyond the curriculum:

IQAC has designed and developed the curriculum of short term courses by taking stakeholder's feedback and provided a strategic deployment plan to enhance the employability and entrepreneurship capacity of the students.

IQAC has evaluated the short term courses proposals and approved to introduce the skill enhancing and value add on courses. Management has permitted to provide infrastructure and financial support to start the courses. The departments have established the Ad-hoc BOS and BOE to design and develop the skeleton, duration of the course, blow up syllabus (theory & experiential), references, question paper pattern, scheme of evaluation, instructions to examiners, list of internal & external examiners, model of marks card and certification.

As per the SOP developed by IQAC, the courses are organized semester wise or annual basis. Each student should opt and complete one certificate course and one or two value added courses before the completion of under-graduate course. The fees for the course is fixed to meet out the expenditure. The minimum of 75% of attendance and 50% of passing percentage is mandatory to obtain the certificate.

Students are motivated to complete at-least one certificate and one value added courses during under graduationand Post graduation.

**Promotion of research culture among Faculty and students.**

To gear up the research activity, IQAC has initiated the teachers to mobilize the funds from UGC/Agencies and Management. The Research oriented faculty prepared the innovative proposals for trans-disciplinary research capacity building and HR management submitted to UGC for the grant under STRIDE Comp-I. Among the three colleges in State our college has awarded with UGC grants. The grant is utilized to organize workshops, Hands on Training, FDP, SDP, National and International seminars/Conferences. The College has continued to move towards quality enrichment in its 4th Cycle

Effective teaching learning and monitoring process:

Since the second cycle of NAAC, IQAC has emphasized on quality enrichment of all aspects of the College. As a result, whenever there have been any changes introduced by NAAC, the College has been prompt in enforcing the rules.

The Demand Ratio of all courses in the College is consistently high. Therefore, the College opted for additional divisions in the College has shifted to Choice Based Credit system from 2016-17.

From the previous cycles, the number of faculties who received doctoral degrees increased from 6 to 13, and the number of faculties who received major/minor research grants increased from nil to 19. To promote ICT in teaching learning, the College has Microsoft Teams, smart boards in 8 class rooms with 180 to 255 computers with internet speed of 10 MBPS to 50 MBPS.

Students are classified as slow and advanced learners based on their performance in the lower exams and class tests, slow learners are given to remedial classes.

The NSS Unit of the College and The Sports Committee is very active, both inside and outside College. To overcome Covid-19 pandemic situation, adopted virtual teaching.
